

Additional Contact Information for UIIA Equipment Providers

A new feature has been added for UIIA Equipment Providers that will allow your company to list multiple contacts under your UIIA Account. EPs may have specific contacts for Per Diem Disputes, M & R Disputes, Binding Arbitration, etc. The ability to list these individual contacts in addition to the main UIIA contact is now available and Motor Carriers will have the ability to see this information.

Here is how it will work –

Once logged into your UIIA account there will be a new option offered on the navigation bar – **ADD OTHER CONTACTS**. Once you click this the screen below will be shown –

From the screen above an EP would click on **ADD USER** and then fill in the information. The Type of Contact field will have some pre-set options, but an EP will have the ability to enter free form text in this field as well should none of the preset selections fit. After entering the contact information, click on **SAVE**.

From the Motor Carrier side, when they click on the EP's company name, the system will show the main UIIA contact, but will also display a link if additional contacts have been provided by the **EP – VIEW ADDITIONAL EP CONTACTS**. See Screen shot below from the Motor Carrier's perspective –
